Appointment of trustees is governed by the Constitution of the charity. Trustees are appointed in Annual General Meeting each year and are authorised to fill vacancies arising through resignation or death of an existing trustee.

Investment Powers

The Constitution authorises the trustees to make and hold investments using the general funds of the charity, but no such investments are presently held.

Constitution, objects and policies

The Charity is established by written constitution and its objects are to relieve and rehabilitate those suffering from Obsessive Compulsive Disorder and to advance and educate generally the general public so as to better understand this condition.

The policy of the Charity continues to be to seek additional finance and support to run the Charity for the benefit of current and future sufferers.

The trustees delegate the day to day responsibility for managing the charity to the administrator.

The Charity holds reserves which amount to over 40% of one-year's expenditure. The trustees consider this is adequate to enable the Charity to maintain its activities.

Activities, achievements and future development

This year to 31 March 2007 has seen some important investments by the Charity. Most importantly we have used some funding to invest in our membership administration and fundraising systems and processes. This will take a little time to get set-up and operating effectively, but we anticipate significant savings in external administration and fundraising costs next year.

The office has continued to provide valuable support to sufferers, has answered many thousands of calls, and sent out in excess of 10,000 information packs.

Our media representative on the executive committee has continued to participate in and facilitate a wide range of press articles and television programmes in order to help raise the profile of the illness and the Charity.

On the financial front, we finished the year in a stable position and thank all our members for their fundraising activities. We continue to rely on successful applications to trust funds for much of our work, and we hope to expand this in the coming year as we look to continue to grow the Charity and the services it provides to its members and the wider pool of sufferers.


Statement of trustees responsibilities

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF OBSESSIVE ACTION

Respective responsibilities of trustees and examiner


Basis of independent examiner's report

NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2007

1 Accounting policies

Basis of preparation of accounts

The accounts are prepared in accordance with the SORP 'Accounting and Reporting by Charities' and the FRSS (2005).

The Charity has taken advantage of the exemption in Financial Reporting Standard No. 1 from the requirement to produce a cashflow statement as it qualifies as a small charity.

Income

Voluntary income and donations are accounted for as received by the Charity. No permanent endowments have been received in the period.

Value added tax

Value added tax is not recoverable by the Charity, and as such is included in the relevant costs in the Statement of Financial Activities.

Fixed assets

Depreciation is provided at the rate of 25% per annum on cost in order to write off the assets over their estimated useful life.

Stocks

These are valued at the lower of cost or market value.
