OCD Action is committed to safeguarding your privacy, and to letting you know how we use any personal information that you provide to us.

Developing a better understanding of our supporters allows us to fundraise more effectively and efficiently. We have made improvements to this policy so that we are more transparent in how we use your personal information in accordance with the law.

Privacy Notice

Data Protection Statement

OCD Action endeavours to meet the highest standards when collecting and using personal information. We are committed to upholding the standards and regulations embodied in the Data Protection Act 2018 (DPA 2018) and the UK General Data Protection Regulation (UK GDPR). Personal data will therefore at all times be:-

- Processed lawfully, fairly and in a transparent manner;
- Collected for specified, explicit and legitimate purposes and not further processed in a manner that is incompatible with those purposes;
- Adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed;
- Accurate and, where necessary, kept up to date;
- Kept in a form which permits identification of data subjects for no longer than is necessary for the purposes for which the personal data are processed; and
- Processed in a manner that ensures appropriate security.

We are committed to ensuring that personal data is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect.

Information will not ordinarily be processed overseas unless there is a specific request for us to do so, such as a need to send staff information to an individual or organisation in another country. If information is to be sent overseas then this will be done in accordance with the Data Protection Act 2018 and the General Data Protection Regulation and under the guidance of the Data Protection Officer and the IT department. The manner in which this will occur will be discussed with you prior to information being sent overseas.

Individual Rights

1. Information kept by OCD Action

OCD Action may keep the following information about you that includes but is not limited to:

- Your name
- Contact details (address, email, phone number)
- Your date of birth
- Records of any contact you may have had with our fundraising team
- Survey response (if you complete a survey and provide your contact details)
- Other details that you provide to us

We may also ask for, or collect, some additional information about you (i.e. your interests or your relationship to OCD Action or OCD as a condition)

This information will be kept on our fundraising database. We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect

2. How we use this information

Your personal information will only be used by us to:

- process your donations, to fulfil online orders, bookings or requests;
- respond to your questions or comments;
- provide or administer services, such as e-newsletters, or training materials;
- provide you with information relating to OCD Action, or that we feel may be of interest to you;
- · maintain our organisational records;
- ensure you are on the correct and most age-appropriate mailing list(s) and that we have parental consent where required by law.

3. Sharing information

OCD Action will not share your personal details with third parties.

OCD Action is subject to a number of regulatory standards and may therefore allow its records to be inspected as part of that process, to ensure that OCD Action is meeting the necessary standards. Inspectors will be given access to records but only provided with copies in exceptional circumstances, for example if a safeguarding concern is identified.

4. Lawful basis

The lawful basis for the processing of this personal data includes: -

Consent

You have consented to us processing your data – for example, all digital communications will only be sent to you, if you have consented to this method of contact. We will seek to update your consent every 36 months, unless we hear otherwise from you;

Contract

There is a contractual relationship with you – for example, the records we keep on any financial support you may have given us;

Legal obligation

We are legally obliged to process your data – for example, HMRC requires us to keep Gift Aid records;

Legitimate Interests

We believe it is in the legitimate interest of either you as the data subject, or us as the charity, to process your data – for example, we may send you details of a fundraising campaign through the post as it is in OCD Action's legitimate interests to circulate this as widely as possible. If you do not want to receive such communication on this basis, please let us know.

Please remember if you do not want to receive information from us, contact us by email at info@ocdaction.org.uk with the word "unsubscribe" in the subject field.

Your consent to receive our marketing communications will apply for approximately 36 months after your last contact or action with us e.g. you make a donation unless you contact us to change your communication preferences. After approximately 36 months we'll contact you to ask if your consent to receive our marketing communications remains. If we do not receive a response, we shall assume

you do not wish to hear from OCD Action by email, phone or SMS and will not contact you again, by these means, until you inform us otherwise.

Please note that OCD Action also complies with the Privacy and Electronic Communications Regulations (PECR).

5. Your communication preferences

OCD Action relies on "opt-in" consent for any email marketing or direct marketing. If you "opt-in" we will email you with news and updates about our work, this includes fundraising appeals, or any other form of marketing from the charity. You can unsubscribe any time by emailing info@ocdaction.org.uk, or by following the "unsubscribe" link in the footer of any marketing email you receive.

Please note that you do not need to opt in to marketing emails to continue hearing from us about a subject for which you've specifically provided us information (e.g. if you're a Member you will still hear from us about your membership even if you don't opt in to marketing emails).

If we wish to use the information for other purposes, we will notify you prior to such use. If you object to any such use, you can e-mail us at info@ocdaction.org.uk and let us know of your objection, and we will not use your information for such purpose. If you wish to have any personal information you have sent to us removed from our database, please e-mail us at info@ocdaction.org.uk with the word "unsubscribe" in the subject field.

We use communications to keep you up to date with what we're doing, how you can get involved, and news and features about the charity which we feel will be of interest to you. This may include newsletters, surveys, financial appeals, raffle appeals, fundraising opportunities or updates about OCD Action services.

We use a variety of methods to send marketing to you including electronic channels, telephone, social media and post.

Electronic communications

These include emails and text messages.

Email

This is where you receive information about OCD Action through your electronic mailbox. Email enables us to contact a wide range of individuals and is an easy way to keep you updated. It allows you to stay up to date with our work, donate and get involved quickly and easily. Telephone

We may contact you by phone to discuss your involvement with OCD Action or as part of a specific fundraising campaign.

Social Media

OCD Action uses social media to communicate with you and share information about campaigns or events. Currently we use Facebook, LinkedIn, Twitter and Instagram, but this may be expanded upon. We do this through advertising on your social media or through posting messages and information on our own social media pages which you may choose to "like", "follow" or interact with.

Post

This is where you receive information about OCD Action through your mailbox. Postal marketing enables us to contact a wide range of individuals and is an easy way to keep you updated. It allows you to donate and get involved in your own time and in a way which is not intrusive for you.

Changing your marketing preferences

You can always tell if you change your mind. You can stop receiving marketing communications altogether or change your preferences at any time either by following the instructions in the communication you have received or by contacting us at info@ocdaction.org.uk with the word "unsubscribe" in the subject field.

6. How long we hold your information for

OCD Action will keep your personal information only for as long as we need to use it for the purposes set out in this policy.

The criteria we use for determining retention periods is based on various legal requirements:

- The purpose for which we hold your personal information, and whether there is legitimate
 reason for continuing to store it (such as in order to deal with any future legal disputes or
 legacy bequests);
- Financial records in accordance with government HMRC requirements;
- Guidance issued by relevant regulatory authorities including, but not limited to, the Information Commissioner's Office (ICO).

If you have asked us not to use your information for marketing purposes we will not do so, but we may retain your details (for example, as on a suppression list) to help ensure we don't continue to contact you.

Personal information that we no longer need is securely disposed of, suppressed, and/or anonymised so that you can no longer be identified from it, as applicable.

We never store payment card details after a transaction has been completed.
